- 2. The Reserve price, below which the property shall not be sold, is Rs 22,44,500/- (Rupees Twenty Two Lakhs Forty Four Thousand Five Hundred only).
- The amount by which the bidding is to be increased shall be determined by the 'Authorized Officer'/auctioneer conducting the sale.
- 4. In the event of any dispute arising as to the amount bid, or as to the bidder, the lot shall at once be again put up to auction.
- 5.
