1. Nominal Size

2. Type

Record protection cabinets shall be of FR120—Cabinets having a fire resisting rating of 120min.

3. General Constructions / Specification

a) Cabinet Construction

Outer body and inner box shall be fabricated from mild steel or galvanized steel sheets of not less than 0.8 mm nominal thickness. The steel parts shall not have any burrs or dents. The cabinet body of the fire resisting record protection cabinet shall be of double wall type with insulating material filled in-between. The insulating material should not produce toxic gases when the cabinet is exposed to fire situation. The components shall be assembled by bolting, welding, riveting or by any combination of these methods.

b) Locking Mechanism

The locking mechanisms shall be of 4 way type. The diameter of shooting bolts shall be 15 mm to 20mm. There shall be minimum three shooting bolts (two shooting bolts for size 1 000) on each side and minimum one vertical shooting bolt each on top and bottom. The shooting bolts shall slide smoothly in recess and engage in body to a minimum depth of 12 mm.

c) Locks

The cabinet shall be supplied with a dual control key lock having minimum 6 levers with duplicate keys. The keys shall be made of stainless steel or any other non ferrous metal/alloy having non-corrosive properties. Minimum two sets of the keys shall be supplied.

d) Handles

Handle can be fixed or detachable. Handles/handle shall be made from ferrous (powder coated/plated), non-ferrous material or polymer.

4. Internal Fixtures

The cabinet shall be provided with minimum four shelves for nominal size 1600. Shelf height shall be adjustable.

5. PAINTING

The inside and outside surfaces of cabinet shall be painted or powder coated. In case of paint an appropriate primer and under coating shall be used in accordance with normal industrial practices. The minimum overall thickness of the coatings shall be 50 microns for powder coatings and 70 microns for liquid paints.

6. MARKING

A metal plate showing type of cabinet together with the manufacturer's name and the year of manufacture shall be fixed on the inner face of the door.

a) Marking on Keys

The keys shall be marked with an identification number which shall not be the same as the serial number of the cabinet.

b) BIS Certification Marking

The record protection cabinets may also be marked with Standard Mark. The use of the Standard Mark is governed by the provisions of *Bureau of Indian Standards Act*, 2016 and the Rules and Regulations made there under.

7. INSPECTION

The purchaser or his authorized representative shall normally have access to the factory to inspect the fire resisting cabinet at various stages of manufacture.

8. PACKING

Each cabinet shall be packed in accordance with the best trade practices, with its door bolted, but not locked. The keys shall be separately sealed in a box or pouch and delivered with FRRCs.

Bids are invited from reputed security item manufacturers/bidders who fulfill all specifications prescribed by the Bank as stated above for supply of FRRCs to various branches in our Bank.

Technical:

- 1. The participating bidder must be BIS certified with BIS certified product i.e. FRRC.
- 2. The participating bidder must be the Original Equipment Manufacturers (OEM) / Authorized Dealer/ Agents supplier. As a proof, Manufacturers / Authorized Dealer/ Agents supplier must have to submit license/certificate issued by competent authority.
- 3. The company/vendor shall not have been blacklisted by any PSU Bank nor should their name be figured in the IBA caution list.
- 4. The vendor should have valid BIS license for the FRRCs with FR 120 min.
- The company/vendor shall have ISO-9000/9001 and ISO 14001 series certifications for manufacturing process. The product / equipment should be quality products and should have Bureau of Indian Standards (BIS) certification and should also meet the minimum fire rating criteria specified by BIS.
- 6. The vendor agrees for random testing of their product bought by the bank at the current BIS test house at the cost of Vendor and must agree for bearing the cost of transportation and testing fee and also agree to replace the tested equipment with the new one without any extra cost.
- 7. Bidder should furnish in the format given below details of any successful fire incidents which occurred on any FRRC manufactured/ supplied by them from the date of starting the manufacturing/suppling to till date. In case there is no FRRC their of make/manufactured/supplied involved in any fire accident then the bidder should give an undertaking on Rs.10/- stamp paper mentioning that "We are not aware or not have been informed by any users that FRRC manufactured/supplied by us has been undergone through such incident".

- 10. Minimum warranty period will be 01 years.
- 11. The bidder/OEM must supply items within 30 days after getting order.
- 12. The bidder (manufacturer or authorized supplier) should have regularly for last 3 [three] years, ending 31st March 2024 of the financial year, manufacturer/ supplied of the FRRCs, with the same or higher specifications as mentioned in the bid document. The bidders should have manufactured and supplied 80 % numbers i.e. 24 FRRCs of 'The Product' in at least one of the last five years ending on 31.03.2024. The FRRC should be in successful operation & maintenance for at least 1[one] year on the date of bid opening.
- 13. The Bidder should have satisfactorily completed similar works (supply of FRRCs) during last 7 (seven) years ending last day of the previous month with Central/State Government Department/Central Autonomous Body/Central Public Sector Undertaking/City Development Authority/Municipal Corporation of City formed under any Act by Central/State Government and published in Central/State Gazette/ Scheduled Commercial Banks or its subsidiaries/Private organizations should be either of the following :

a)One similar nature work costing 80% of the estimated ≥ cost. b)Two similar works costina ≥ 50% nature (each) of the estimated cost. c) Three similar nature works (each) costing \geq 40% of the estimated cost.

- 14. The average annual financial turnover of 'The bidder' during the last three years, ending on 31st March 2024, should be 80% of the estimated bid value as per the annual report (audited balance sheet and profit & loss account) of the relevant period, duly authenticated by a Chartered Accountant/ Cost Accountant in India.
- 15. The net worth of the Bidder firm (manufacturer or authorized supplier/dealer) should not be negative on 31st March 2024 & should have not eroded by more than 30% (thirty percent) in the last three years, ending on 31st March 2024. In cases where audited balance sheet of last financial year is not available then provisional balance sheet certificate duly authenticated by a Chartered Accountant/ Cost Accountant in India will be considered.
- 16. The EMD of Rs. 56000/- shall be accepted in the form of Insurance Surety Bonds, Account Payee Demand Draft, Fixed Deposit Receipt, Bankers' Cheque or Bank Guarantee (including e-Bank Guarantee) (from any Scheduled Commercial Bank other than Sarva Haryana Gramin Bank) issued in favor of Sarva Haryana Gramin Bank, Regional Office, Bhiwani, payable at Bhiwani or online payment in our Bank's account no. 81823171160 having IFSC PUNB0HGB001. - 17. Relaxations from submission of EMD shall only be given to the Start-ups recognized by Department of Industrial Policy & Promotion (DIPP) and MSE's having valid Udhyam registration Certificate.
- 18. Bank will keep 8% of interim invoices subject to 5% of total contractual procurement value as retention money till the completion of warranty/guarantee period. The bidder/supplier shall attend to all defects noticed during defect liability period. If the bidder/supplier fails to attend the defects, these defects will be rectified by the bank and the expenditure incurred on this account shall be recovered from their security deposit/retention money.
- 19. Bidder will be entitled for liquidated damages per week delay for the quantum of 0.50% of the contract amount shown in the tender subject to maximum of 7.50% of the accepted contract sum.
- 20. The liquidated damages as mentioned above may not be enforced if the bidder/supplier applies for extension of time mentioning the reasons for extension. Extension of time in days may be granted by the Bank at its own discretion if it is proved that bidder/supplier is not at fault for extending the work beyond stipulated date of completion.
- 21. All alterations in the tender should be initiated by the authorized signatory. Over writing may invite disqualification of the tender.
- 22. Documents to be uploaded in Technical Bid:
 - a) Latest copy of BIS license.
 - b) General Profile of the company/dealer.
 - c) Contact Person with their contact numbers and email addresses.
 - d) Latest copy of requisite certificates.
 - e) GST certificate.

23. The Bank reserves its rights to split the order in the ratio 50:30:20 (percentage) amongst upto three bidders/suppliers at its sole discretion.

Financial:

- 1. The rates should be actual and nearest to the market rates. The Bidders should not quote the Freak Rates. The Bank have right to cancel bids of those bidders if found freak rate in the tender rate.
- 2. The payment of the bills will be made by Bank after satisfactory receipt of the goods verified by concerned branch office.
- 3. The amount to be quoted in figures as well as in words. In case there is any variance in these two rates, the amount; written in words shall be taken as final.
- 4. The rate quoted shall be **valid for a period of 90 days after the date of opening of the Financial Bid.** No escalation in the rates will be allowed under any circumstances.
- 5. The payment will be made after supply of FRRC(s) to all branches as per list mentioned in **Annexure- D**, installation of security equipment's (subject to confirmation from Branches) and after keeping amount of 8% of interim invoices subject to 5% of total contractual tender cost as retention money for defect liability period.
- 6. The rates quoted shall be inclusive of cost of all material/accessories, Labour, taxes (inclusive GST), levies/octroi, transportation to site and hand over to concerned officials etc.
- 7. No advance will be paid to any vendor during supply and installation of security equipments.
- 8. "Financial Bid" must be uploaded as per the financial bid **(Annexure A)** only. Financial Bid other than as per **Annexure-A** will not be entertained.

General:

- 1. The mode of submission of tender is online only on GeM Portal; tender submitted in any mode other than specified will not be entertained by the Bank.
- 2. The bid evaluation committee of Sarva Haryana Gramin Bank Regional Office Bhiwani shall conduct the evaluation on the basis of the submitted Technical Bid. However, Sarva Haryana Gramin Bank, Regional Office Bhiwani may seek clarification on the information submitted by the bidder, if required.

- 3. In case of any dispute, the matter will be referred to the Regional Manager, Sarva Haryana Gramin Bank, Regional Office Bhiwani. For litigation, if any arising thereof, the competent court (local) alone shall have jurisdiction.
- 4. Bank reserves the right to accept or reject or cancel any or all tender/s without assigning any reasons whatsoever and the said decision shall be final and binding upon the bidders.

- 6. If defective items are received, then company will replace the same, without any cost to the bank within 7 days.
