1. Remuneration: A fixed consolidated	amount shall be	paid as under:

The amount of remuneration so fixed shall remain unchanged for the term of the contract. There will be no annual increment/percentage increase during the contract period. Remuneration will further be subject to as per the guidelines issued by the Department of Expenditure and also as per guidelines, if any, issued by the DOP&T and DPE from time to time.

The retired Government servant engaged shall continue to draw pension and dearness relief during the period of contract. Their engagement in NSFDC shall not be considered as a case of re-employment.



2. <u>Period of engagement</u>: Consultants shall be engaged initially for a period of 6 months which may be extended depending on the requirement and performance review of the Consultants. The engagement of Consultants would be on full-time basis and they would not be permitted to take up any other assignment during the period of Consultancy with the NSFDC. The engagement can be cancelled at any time by the NSFDC without assigning any reasons.

3. <u>Place of Posting:</u> Initial posting will be in Delhi. However, as the project will be implemented on Pan India basis, the Consultant will be required to travel extensively at the project site and also liable to be posted anywhere in India.

4. <u>Allowance</u>: They will not be entitled to any other allowances such as Dearness allowance, HRA, CGHS, medical reimbursement etc. or any other pecuniary benefits as admissible to the other regular employees of the Corporation.

5. <u>TA/DA and other Boarding/Lodging Charges</u>: shall be payable as per entitlement applicable to the existing executives of equal grades wherever tours are undertaken for the jobs related to the assignment.
