The tender must enclose any two KYC documents (Aadhar Card, PAN Card, Driving License, Passport etc.) Proposals should reach our Head Office, Rohtak on or before (2009 202) (up to 02:00 P.M.). Please mark your Contact No. on the envelope of the tender. Unsealed/Tempered Tenders, if any, will be summarily rejected.
- 2. The tender received without EMD (Bank Draft) and after the stipulated date and time, will not be accepted.
- 3. Separate Demand Draft of EMD for Rs. 20000/- must accompany with the proposals for each vehicle and DD should be in favour of 'SARVA HARYANA GRAMIN BANK payable at Rohtak'.
- 4. The tender will be opened on Og. 09. 2022 at 03:P.M. at Sarva Haryana Gramin Bank, Head Office, Plot No. 1, Sector-3, Rohtak, HR-124001 in the presence of the tenderers, who wish to be present. In case bid is not open on the above mentioned date due to any exigency, the bid will be opened next working day at 03:00 P.M.
- 5. Vehicle may be inspected on any working day before last date between 03.00 P.M. to 5:00 P.M.
- 6. Successful tenderer will have to deposit entire amount after adjusting EMD amount within 7 days from the date of intimation from the Bank in this regard. In case successful tenderer fails to deposit money, the EMD will be forfeited.



- 7. Only the highest bid amount in and above the minimum reserve price will be accepted. If the highest bidder (H-1) refuses to purchase the vehicle, the same may be sold to H-2 on the rate quoted by H-1
- 8. Further physical possession of vehicle will be given only after furnishing proof of RC duly transferred in favour of the successful bidder within a period of 1 month.
- 9. The vehicle will be delivered only after the receipt of full payment and has to be lifted within 03 days after furnishing proof of RC duly transferred in favour of the successful bidder, failing which ground rent at the rate of Rs. 200/- per day will be charged. Cost of Registration & other charges will be borne by the purchaser.
- 10. In case successful bidder desires to re-register the vehicle outside Haryana, where the vehicle needs to be produced physically, at the cost of bidder, subject to return the vehicle till transfer of RC, an extra amount of Rs. 25,000.00 has to be deposited other than EMD, which will be refundable only after furnishing proof of RC duly transferred in favor of the successful bidder within a period of 1 month. Once the release order issued, Bank will not be responsible either for safe custody or for any loss or damage to the subject vehicle and/or to any third party. If the vehicle is handed over to successful bidder & RC is not transferred, the Bank will not be held liable for any consequences arising from misuse of vehicle like accident, damaged to vehicle or third party, unlawful activity, Traffic Challan, fines etc.
- 11. The highest bid once accepted is not transferable to anyone. Request to change the name of the bidder in the tender after submission of the tender will not be entertained.
- 12. In case the bidder is a company/firm, the name of company/firm should be indicated as the bidder. In such cases the person appearing for the company/firm should have the authorization letter in a proper format issued from a competent authority of the company/firm.
